Privacy Policy

Echt Skene & Midmar Agricultural Association ("We") are committed to protecting and respecting your privacy.

This policy sets out the basis on which any personal data we collect from you, or that you provide to us, will be processed by us. Please read the following carefully to understand our views and practices regarding your personal data and how we will treat it.

The rules on processing of personal data are set out in the General Data Protection Regulation (the "GDPR").

1. Definitions

Data controller - A controller determines the purposes and means of processing personal data.

Data processor - A processor is responsible for processing personal data on behalf of a controller.

Data subject – Natural person

Categories of data: Personal data and special categories of personal data

Personal data - The GDPR applies to 'personal data' meaning any information relating to an identifiable person who can be directly or indirectly identified in particular by reference to an identifier (as explained in Article 6 of GDPR). For example name, passport number, home address or private email address. Online identifiers include IP addresses and cookies.

Special categories personal data - The GDPR refers to sensitive personal data as 'special categories of personal data' (as explained in Article 9 of GDPR). The special categories specifically include genetic data, and biometric data where processed to uniquely identify an individual. Other examples include racial and ethnic origin, sexual orientation, health data, and trade union membership, and political opinions, religious or philosophical beliefs.

Processing - means any operation or set of operations which is performed on personal data or on sets of personal data, whether or not by automated means, such as collection, recording, organisation, structuring, storage, adaptation or alteration, retrieval, consultation, use, disclosure by transmission, dissemination or otherwise making available, alignment or combination, restriction, erasure or destruction.

Third party - means a natural or legal person, public authority, agency or body other than the data subject, controller, processor and persons who, under the direct authority of the controller or processor, are authorised to process personal data.

2. Who are we?

Echt Skene & Midmar Agricultural Association is the data controller. This means we decide how your personal data is processed and for what purposes. Our contact details are: secretary@echtshow.co.uk or The Secretary, Barnton Farm, Echt, Westhill. Aberdeenshire AB32 6XA

3. The purpose(s) of processing your personal data

We use your personal data solely for the purposes of Echt Skene and Midmar Agricultural Association, which include:

1. To renew membership.
2. To publish a catalogue of exhibitors/judges for our agricultural show.
3. To enter competitions, trade stands at our annual agricultural show.
4. To promote our agricultural show.
5. To pay prize money following the agricultural show.
6. To pre-order tickets for fundraising events.
7. To enter into contracts with suppliers in order to comply with health & safety.
8. To comply with legal regulations.
9. To provide photographs/videos for press release.

4. The categories of personal data concerned

With reference to the categories of personal data described in the definitions section, we process the following categories of your data:

Personal data:

Name; Address; Telephone number; Mobile number; E-mail address; Bank details;

Photographs; Video

It is stored electronically and password protected and in paper form in a locked filing cabinet.

5. What is our legal basis for processing your personal data?

a) Personal data (article 6 of GDPR)

Our lawful basis for processing your general personal data:

Consent of the data subject.

Processing necessary for the performance of a contract with the data subject or to take steps to enter into a contract.

Processing necessary for the purposes of the legitimate interests of the data controller or a third party, except where such interests are overridden by the interests or fundamental rights or freedoms of the data subject.

6. Sharing your personal data

Your personal data will be treated as strictly confidential, and will be shared only with members of Echt Skene & Midmar Agricultural Association committee, third parties connected with the Association and to comply with legal and regulatory bodies.

We only provide a name and area of residence when publishing our catalogue of entries at our agricultural show e.g. John Smith, Echt

We may use videos or photographs taken at the agricultural show for promotional, educational, marketing and communication purposes and may also be published on our website, social media and other digital platforms.

How long do we keep your personal data?

We keep your personal data for no longer than is necessary for a period of 5 years /for the length of time necessary to perform the processing for which it was collected or until such time that you withdraw your consent and exercise your right to request that we delete your personal data. Once information is no longer needed it will be disposed of securely. Paper records will be shredded or disposed of in confidential waste facilities and electronic records will be permanently deleted.

7. Your rights and your personal data

Unless subject to an exemption under the GDPR, you have the following rights with respect to your personal data:

- The right to request a copy of the personal data which we hold about you;
- The right to request that we correct any personal data if it is found to be inaccurate or out of date;
- The right to request your personal data is erased where it is no longer necessary to retain such data;
- The right to request that we provide you with your personal data and where possible, to transmit that data directly to another data controller, (known as the right to data portability), (where applicable i.e. where the processing is based on consent or is necessary for the performance of a contract with the data subject and where the data controller processes the data by automated means);
- The right, where there is a dispute in relation to the accuracy or processing of your personal data, to request a restriction is placed on further processing;
- The right to object to the processing of personal data, (where applicable i.e. where processing is based on legitimate interests (or the performance of a task in the public interest/exercise of official authority); direct marketing and processing for the purposes of scientific/historical research and statistics).

8. Transfer of Data Abroad

We do not transfer personal data outside the EU.

9. Automated Decision Making

We do not use any forms of automated decision making in our business.

10. Further processing

If we wish to use your personal data for a new purpose, not covered by this Data Privacy Notice, then we will provide you with a new notice explaining this new use prior to commencing the processing and setting out the relevant purposes and processing conditions.

11. Changes to our privacy policy

Any changes we may make to our privacy policy in the future will be posted on our website and where appropriate, notified to you by e-mail.
