**Food Fayre Exhibitors Regulations and Guidelines**

In order that you are aware of what is required of you on Show day, you must read and abide by the regulations and guidelines below. You must sign the application form to confirm that you have done so. **Exhibitors are required at all times to follow instructions issued to them by the Show's Trade Stand Stewards, office bearers and committee members.**

1. Entrance to the Showground is permitted from 7am on Saturday when Stewards will direct you to your allotted space. All vehicles must be removed from the Show field to the car park immediately after unloading. There is no charge for parking at the Show. You will receive 2 complimentary entry passes.
2. Exhibitors are responsible for the erection of their stands and are required to have their merchandise in place by 9.00 am on show day. Goods displayed must be in accordance with the description given on the Entry Form. Stands must be open and continuously manned from 9.30am onwards.
3. Please ensure your Exhibitor's name and address is prominently displayed on your table.
4. All Exhibitors must comply with the Health and Safety Regulations and Food Safety Act 1990 or the current equivalent.
5. Electricity is available (see application form) by arrangement. By law all electrical appliances need to be P.A.T. tested, and certificates must be readily available for inspection on Show day.
6. There are cold water taps in place around the Show field.
7. Exhibitors are responsible for the security of their entries. The organisers will not be held responsible for loss or damage to stands or exhibits however caused.
- 8 The dismantling of Stands is permitted from approx.5pm.
9. The organisers will not be responsible for any accident caused by the exhibitors stand, or exhibits, or personnel, including machinery or equipment belonging to any exhibitor. It is a condition of entry that exhibitors shall hold the organisers blameless and indemnify the organisers against any legal proceedings or claims arising from any accident caused by the aforesaid.
10. The use of mechanical loud speaking appliances is prohibited.
11. In the event of the Show being terminated early due to inclement weather, or for any other reason, there shall be no refund of fee.
12. Any complaints must be made in writing to the secretary before 6p.m. on the day after the Show. The committee shall reserve the right to decline applications in future years from those making derogatory comments about the Show or persons connected with the Echt Show on social media.
13. Trade Stand Competition: Each stand will be judged after 11am for the best display. The winner will receive a Trophy to be returned on Show day next year.
